Notes:

- **Released:** All Quarterly Report data through QR Round 22 (Q1 2024 - Q2 2024) submitted by these countries have been processed and are now available in M-DIVE.
- **Partially released:** These countries have been contacted to either 1) ask for confirmation of suspected data anomalies and/or ambiguities, 2) ask for further clarification about how their data should be processed, or 3) request missing data. While we continue to work with the teams of these countries, we have processed the rest of their data and approved it to be included in the Malaria Quarterly Report. As remaining issues are resolved, and updated data are submitted, processed and approved, we will communicate our progress to the in-country team and update the Malaria Quarterly Report.
- **In Progress:** Data processing for these countries is in progress due to on-going work on resolving data issues or late submissions. Countries marked as “in progress” may also have partially released data, or no released data when all data are undergoing processing.
- **Updated standard geographic names:** When a country changes their geographic boundary names due to redistricting, the changes may be reflected in M-DIVE and will be indicated in this column.
- **Shapefile Status:** Includes information about the source from which Civis obtained the country’s shapefiles, the year the shapefiles were updated, and the geographic levels available for the shapefiles.
