## New M-DIVE Features

- Data Updates
  - Quarterly Report Round 8 Data Updated (Q4 2020 + Q1 2021)
    - Released (22): Angola, Benin, Cambodia, Cameroon, Côte d'Ivoire, DR Congo, Ethiopia, Ghana, Kenya, Liberia, Madagascar, Mali, Mozambique, Myanmar, Nigeria, Rwanda, Thailand, Tanzania (Mainland and Zanzibar), Thailand, Uganda, Zambia, Zimbabwe
    - Did not submit data this round (6): Burkina Faso, Guinea, Malawi, Niger, Senegal, and Sierra Leone
- DHIS2 connection:
  - This round, 7 countries used a direct connection between M-DIVE and DHIS2 to submit their HMIS data. If you would like to submit HMIS and/or LMIS data through DHIS2, please reach out to the PMI Data Integration team. - Malaria Quarterly Report
  - **Custom Admin Mappings:** (continued from Q1 2021) Our system for standardizing geographical names ("Admin Alignment") maps geographical names in the submitted QR data to a list of standardized names ("canonical" names). Our canonical names currently support up to five levels of administrative subdivisions (not including the country-level itself). The Malaria Quarterly Report currently supports up to two geographical subdivision levels. By default, these were set to the first and second subdivision levels. We've expanded our logic introduced in Q1 2021 allowing in-country teams to specify which admin names should be displayed as the first and second level admin names in the Malaria Quarterly Report. Most countries still use the first and second administrative levels, we've listed the updated exceptions below :
    - Benin: 12 Departments (level 1) and 82 Communes (level 3)
    - Burkina Faso: 13 Regions (level 1) and 70 Health Districts (level 3)
    - Côte d'Ivoire: 33 Regions (level 2) and 113 Health Districts (level 3)
    - Myanmar: 19 Regions + States (level 1) and 84 Districts (level 3)
    - Uganda: 15 Counties (level 2) and 135 Sub-Counties (level 3)

Please let us know if you would like the Malaria Quarterly Report to use a different administrative level than the ones currently displayed!

- Year-over Year Tab:
- The QR Dashboard's Year-over-Year tab allows M-DIVE users to explore how select QR indicators are changing over time. Since the previous release, our team

has added reactivity to the date filters for this tab and added labels to increase the transparency of these calculations.
