- **Data Updates**

- **Quarterly Report Round 11 Data Updated (Q2+Q3 2021)**

- Released (18): Angola, Benin, Cambodia, Cameroon, Côte D'Ivoire, Ethiopia, Ghana, Kenya, Madagascar, Mali, Mozambique, Myanmar, Niger, Nigeria, Rwanda, Tanzania (Zanzibar), Uganda, Zimbabwe
 - Partially released (6): Guinea, Liberia, Malawi, Tanzania (Mainland), Thailand, Zambia
 - In progress (1): DR Congo
 - Did not submit data this round (3): Burkina Faso, Senegal, Sierra Leone

Note: We have identified various countries as *Partially released*. These countries have been contacted to either 1) ask for confirmation of suspected data anomalies and/or ambiguities, 2) ask for further clarification about how their data should be processed, or 3) request missing data. While we continue to work with the teams of these countries, we have processed the rest of their data (submitted prior to 12/6/2021) and approved it to be included in the Malaria Quarterly Report.

- As any remaining issues get resolved, and updated data is submitted, processed and approved, we will communicate our progress to the in-country team and update the Malaria Quarterly Report.

- **Updated the standard geographic (canonical) names** for Niger, Senegal and Zambia, based on feedback from the FY2021 MOP Templates.

- **DHIS2 connection:**

- This round, 8 countries used a direct connection between M-DIVE and DHIS2 to submit their HMIS data.
